#### **ACTION AGENDA**

#### **RECOMMENDATION:**

That the Board of Directors appoint a Director to serve NCFPD Division 1.

#### **BACKGROUND:**

Director David Kennedy resigned from the NCFPD Board of Directors effective June 1, 2022. The remaining Board members are now tasked with filling that vacant seat through appointment.

#### **DISCUSSION:**

Per NCFPD Policy 110.015 *Elections, Officers and Terms*, the District has posted a notice of the vacant Board seat in several places within the District, and also in the Village News and Social Media (Government Code §1780(d)). As a result, the District did receive applications from perspective Board candidate(s). During this special meeting, candidate(s) will be coming before the Board to answer questions and share their experiences on why they would be a good selection.

After speaking with the Registrar of Voters, it has been determined that once the Board chooses an appointee, the appointee serves until the next general election, which will be held in November of 2022. The officer elected in November would serve a "short term." This means the seat filled in the 2022 election would be open again for election on the cycle approved in Resolution 2021-13, which for Division 1 is November of 2024.

If the Board is unable to reach consensus on an appointee, the following course would occur. If the District Board has not called for an election within 60 days of the date the District board is notified of the vacancy or the effective date of the vacancy, whichever is later, then the Board of Supervisors of the county representing the larger portion of the district area in which the election to fill the vacancy will be held, may appoint a person to fill the vacancy within 90 days of the date the district board is notified of the vacancy or

the effective date of the vacancy, whichever is later, or the Board of Supervisors may order the district to call an election to fill the vacancy (Government Code §1780(f)(1)).

#### FISCAL ANALYSIS:

The appointment would have minimal cost to the District. Assuming the Board makes an appointment, other fiscal impact to the District is dependent upon the costs associated with the additional seat required for the general election. The cost of an election would have to be determined through analysis through the Registrar of Voters.

#### **SUMMARY:**

Once an appointment is made, the Board Secretary will notify County elections of the appointment within fifteen (15) days (Government Code §1780(d)). Staff will also begin the on-boarding process for the appointee. This would include 700 form submission, ethics training and other District-governed procedures.

I was elected by the people of Fallbrook as a member of the Fallbrook Community Planning Group in November of 2020. I have consistently used my position and platform to advocate for our Fallbrook community. I am proud to have accomplished so many things for the people of Fallbrook in the past two years and all of those achievements are due to the support I received from the community. As a member of the Planning Group, it is my responsibility to serve the community as a whole; however, I strive to represent the neighbors in my nearby community first.

I have lived in D1 since I moved to Fallbrook several years ago. As a renter in the downtown area, I am able to relate to many of the struggles facing my neighbors. 58% of D1 are non-homeowners of which 46% are renters/mobile homes (compared to 40% of Fallbrook as a whole). Even though I am not Latinx, I understand that the District is 68% Latinx under the current map and 73% under the new map. I am an advocate for the Latinx community in Fallbrook and have been endorsed by Voces de Fallbrook, both in my 2020 race for the Fallbrook Planning Group and now in my candidacy for the appointment to this vacancy. I'm proud of my endorsement by the elected representatives of this downtown district including Stephanie Ortiz, Fallbrook Regional Health District, Ricardo Favela, Fallbrook Union Elementary School District, and Oscar Caralampio, Fallbrook Union High School District.

I am highly aware of the activity of our North County Fire Protection District as nearly one half of all calls are from this downtown area. I understand that serving this district is no light undertaking. I have attended meetings of the North County Fire Protection District for over a year and have become familiar with many of the challenges facing the District. From managing recruitment and retention difficulties to pursuing innovative outlets for funding, there is no shortage of obstacles facing the District. It's imperative that the next Director for D1 steps into the position with a history of community organizing and governmental affairs experience.

While serving on the Planning Group, I have been able to pursue my passion for public safety while serving on the Circulation Committee. I am proud to have advocated for a sidewalk

to be constructed from Iowa Street to Brandon Street but secured that project as Number 3 of the 22 projects on the Planning Group's Priority List which has been submitted to the San Diego County Department of Public Works. I also believe the community must be involved in the decision-making process, which is why I created such a robust social media presence that reached nearly 22,000 impressions (posts being seen) in 2021. When the Planning Group was considering a new name for the park on Fallbrook Street, I sought out community input by launching a poll and invited all members of the community to participate, even the elementary schools. Listening to community input is imperative for public servants and I understand that I can't wait for people to come to me, it's my job to go to them.

Serving as a representative for Fallbrook at-large on the Planning Group, including serving as the Board Secretary, led me to organize on behalf of our community (in particular our 48% Latinx population) during the county and state's decennial redistricting efforts. Through partnerships with community groups like Voces de Fallbrook and coalition building, our efforts were able to distribute nearly 30,000 emails to Fallbrookians with pre-written scripts that highlighted our community needs and recognized our regional identity. Due to the 397 comments received mentioning Fallbrook, the Commissioners universally agreed that Fallbrook must remain part of a North County district. (Comparatively Oceanside had 470 comments, which is a city more than triple our size.) So many comments were received for the state redistricting efforts through the email campaign talking about Fallbrook (1,017 comments), that the California Independent Redistricting Commission had to pull Fallbrook up on the map to see the source of the flood of comments. However, I did not stop there. I also led the effort for the Fallbrook Planning Group to send not one, but two letters to the Commission advocating for the 55,000 people of Fallbrook. I drafted both letters and both were passed unanimously by the Planning Group members. Because of this initiative with Fallbrook being the first community planning group to take official action, other planning groups began to send letters to the Commission after seeing the success of Fallbrook.

In conclusion, I have a history of serving Fallbrook as a community advocate and am relentless in my commitment to Fallbrook. As an elected member of the Planning Group, advocating for public safety projects, and ensuring the voice of Fallbrook is heard loud and clear during the redistricting efforts, I have a track record of supporting Fallbrook and its downtown neighbors. I would be honored to join the Board of Directors to continue that advocacy as a representative for District 1.
